Trustees' Report for the year ended 31/12/2008

The Trustees present their report on the activities of the Association for the year ending 31st/ 12mo / 2008.

Background

This Quaker charity exists to provide those who are visually impaired with audio access to Quaker periodicals and books at low cost. The Association was founded in 1988 under the care of Dorking and Horsham Monthly Meeting and responsibility for its care transferred to Warwickshire Monthly Meeting (WMM), now known as Central England Area Quaker Meeting (CEAQM), during 2007.

Members of CEAQM began recording The Friend onto cassette tapes for visuallyimpaired subscribers in October 2007.

The objectives and rules of the Association are defined in its Constitution.

Trustees and Committee Members

The Constitution of the Association requires that there shall be not less than 3 Trustees:

- (b) Trustees shall be appointed by Dorking and Horsham Monthly Meeting of the Religious Society of Friends (Quakers), (or by any body to which its functions are transferred in whole or part from time to time), from amongst persons who are and remain Members of the Religious Society of Friends (Quakers).
- (c) A Trustee shall automatically resign on ceasing to be a member of the Religious Society of Friends (Quakers).
- (d) Persons appointed as Trustees may retire at any time of their own volition or at the request of the Appointing Body for the time being.

Note 1: Appointed for three years up to the 2010 AGM. Other Committee members are appointed for one year, and may be re-appointed subject to their consent at the following AGM.

Eleanor Tew was co-opted as technical advisor on 3/7/2008 and hopes to take up this appointment in mid-2009.

Trustees meet with Committee members at least four times in each year.

Trustees and Committee members have a wide range of relevant qualifications and experience, and the Committee includes, as required by the Constitution, one member who is visually-impaired.

Objectives and Activities

The object of the Association is 'to relieve the blind, or the partially sighted, or those labouring under some temporary or permanent incapacity or disability which makes reading a strain, by the provision of equipment, materials and facilities all of whatsoever nature or description to provide for audible reproduction of printed or spoken material and music or tactile reading matter'.

Members of Talking Friends may subscribe to any or all of *The Friend*, *Quaker Monthly*, *Friends Quarterly* and *Towards Wholeness*. All subscribers receive the cassette version of *Quaker News*. New subscribers also receive a copy of the cassette version of *Advices and Queries*.

Achievements

During 2008 the Association continued to record these Quaker publications onto cassette tapes and to distribute these to visually-impaired subscribers.

The Association has maintained its membership of subscribers and ended the year with 45 members. The incidence of visual impairment increases with age, and so it is natural that most members are in the older age groups. We continue to welcome new members, and hope that the service will be publicised and used more widely.

There are 22 Friends who read The Friend, a weekly publication, onto tape, working in 9 teams representing 8 Local Quaker Meetings within CEAQM. Other Quaker journals are read by Friends in CEAQM and other Area Meetings.

In the past, Quaker books have been recorded on demand by volunteers. No books have been added to the list held on the Association's website this year.

The publications that we make available in audio form are 'Quaker' in origin but accessible to all. We publicise our service to members and attenders of the Religious Society of Friends in the UK and through our website: www.talkingfriends.org.uk

We have started to investigate newer technology for recording and distributing these audio publications. We have sought the views of our subscribers, one of our trustees has evaluated the technical options, and we have carried out a trial recording of The Friend in a CD-based format.

We have updated our publicity leaflet to improve accessibility.

We thank our volunteer readers for their continued commitment and expertise, and we also wish to thank Friends at Quaker Life for copying and distributing recorded material on our behalf.

The Future

1 Our context

We are an independent charity within the Quaker 'family' and so will be guided to reflect joyfully on the recent determination of priorities for Quakers in Britain for 2009- 2014 published in 'A Framework for Action', a strategic focus for activity.

2 Distribution of the Talking Friend

Recorded materials are copied and distributed by staff at Quaker Life, based at Friends' House, London, who generously took over this task in 2006. We are discussing with Quaker Life Central Committee the possibility of transferring this task elsewhere. As before, our objective will be to avoid any disruption in our service to our subscribers.

3 Transfer to new technology

Producing Quaker published materials in alternative formats is an important way of honouring Britain Yearly Meeting's commitment to equality.

Our recordings are made on 'compact cassette' tapes, which was the standard format used by organisations offering 'talking books'. This 1960's technology is being replaced by newer, digital media.

We hope to continue work on the evaluation of alternative systems, which has already included an appraisal of a CD-based system.

We are asking our subscribers for their views on, and their access to, newer audio technology such as CD players and the internet, and their preferences for such systems.

A transfer to new technology is likely to require a relatively large investment in replacement equipment, and may require additional fund-raising.

4 Our Volunteers

We have noted our thanks to those who volunteer to read for us. We recognise the need to nurture and support our volunteers and to anticipate the need to plan succession for those readers who 'lay down' their service to the Association.

Examiner

We thank our Examiner, Peter Ullathorne, a member of CEAQM, for examining our 2008 accounts. He has indicated his willingness to accept reappointment as examiner of our accounts for a further year.
